- 1. To waive any and all claims that I may have against the Club or its directors, members or employees or any other person in any way associated with the Club (all of whom are hereafter referred to as "the releasers"); and
- 2. To release the Club and the Releasers from any and all liability for any loss, damage, injury or expense that I or my guests may suffer as a result of my participation in the sport of sailing or by the use of the Club's facilities and equipment due to any cause whatsoever; and
- 3. To hold harmless and indemnify the Club and the Releasers from any and all liability for any property damage or personal injury to any third party resulting from my participation in sailing or use of Club's facilities, equipment and property; and
- 4. That this Release of Liability shall be in effect and binding upon my heirs, next of kin, executors, administrators and assign in the event of my death; and
- 5. Pay for any damages due to negligent use of equipment.

I have read and understand this Release of Liability prior to signing it and I am aware that by signing the Release of Liability, I am waiving certain legal rights, including the right to sue, which I or my heirs, next of kin, executors, administrators or assigns may have against the Club and the Releasers for time in perpetuity.
